

Petition for a Private Bill: To Provide a Sovereign grant for those who are born in Parts beyond Sea, including Lord Lancelot Junior Webb and his Family

To the Honourable the Commons of the United Kingdom of Great Britain and Northern Ireland in Parliament assembled:

The Humble Petition of Lord Lancelot Junior Webb of the Webb family cost of Arms chartered in the Royal peculiar in Westminster, churchmen of the parishes of Middlesex, Imperial member of the House of Windsor, Heir to the Crown of England, descendant of the house of Wessex, dwelling at 5 Carisbrooke Court, Station Approach, Cheam Ward, Sutton, SM2 7BN.

Sheweth:

The Windrush Generation of the Commonwealth realms are all subject to the Crown colonies and fundamental law of the realm of England and Wales.

The Windrush Generation of the Commonwealth realms have been refused their right to abode in the United Kingdom with hindrance, which is against human rights and equality.

This Petition will help save children, adults and the elderly from discrimination, torture, suffering and death by wrongful administration.

That by virtue of a statute enacted in the twenty-fifth year of the reign of King Edward the Third, titled "1350 Chapter 0 (25 Edw. 3), A Statute for those who are born in Parts beyond Sea," individuals born outside the sovereign territory of England and its dominions are afforded certain rights and recognitions equivalent to those born within the realm.

That the aforesaid statute, grounded in principles of fairness and equality, was established to acknowledge the legitimate rights and standing of individuals born "in Parts beyond Sea" and their capacity to serve the Crown and contribute to the welfare of the realm.

That Lord Lancelot Junior Webb, an esteemed subject of the Crown, was born in Parts beyond Sea and has demonstrated unwavering loyalty and distinguished service to the United Kingdom, deserving recognition and support in accordance with the spirit of the aforementioned statute.

That notwithstanding the enduring relevance of the statute, there exists at present no provision for a sovereign grant or financial aid specifically designed to support individuals born in Parts beyond Sea who have dedicated their lives to the service of the Crown and the betterment of the realm.

That it is therefore expedient and just to enact a Private Bill to extend a sovereign grant to such individuals, ensuring equitable treatment and honoring the historical commitments enshrined in the statute of King Edward the Third.

Wherefore, your Petitioner humbly prays that your Honourable House be pleased to:

Introduce and enact a Private Bill providing for a sovereign grant to individuals born in Parts beyond Sea, who meet eligibility criteria aligned with the spirit and purpose of the statute of King Edward the Third (1350 Chapter 0, 25 Edw. 3).

Include within the scope of such legislation the specific case of Lord Lancelot Junior Webb, recognizing his contributions and granting him the rights and privileges afforded by the proposed sovereign grant.

Establish guidelines for the administration of the sovereign grant to ensure its fair and equitable distribution to qualified individuals, with due regard to their contributions to the Crown and the realm.
