

## **Lancelot Private Bill**

To the Honourable the Lords Spiritual and Temporal, and the Commons, in this present Parliament assembled,

The Humble Petition of Lord Lancelot Junior Webb at Cheam Ward, Sutton

Respectfully Sheweth:

WHEREAS it is the sovereign will and intent of the undersigned to affirm and declare independence, issuing letters patent to establish and proclaim the sovereignty and rights conferred therein, titled as the "Lancelot THE FIRST Bill," enacted on this sixth day of January in the year of our Lord Two Thousand and Twenty-Five, by the grace of God, King of Jamaica, England, Scotland, France, Spain, Liberia, Lydia, Egypt, Ethiopia, Congo, and Ireland, Defender of the Faith, etc.,

AND WHEREAS these letters patent, issued with full legal force, purpose to:

Acknowledge and affirm the independence of the Kingdom of East Anglia, Essex, Kent, Mercia, Northumbria, Sussex, and Wessex

Establish "The King's Men" as an authorized and recognized body of governance, representation, and enforcement of the declared realm.

Enact and incorporate the Book of Common Prayer as the foundational text for spiritual and moral guidance within said jurisdiction.

AND WHEREAS the provisions of this Bill further recognize and reaffirm historical legal principles, including but not limited to:

The invalidation and voidance of monopolies, grants, dispensations, and penalties contrary to public welfare, as repealed and amended by historical statutes, including the Statute Law Revision Act 1863, the Administration of Justice Act 1965, the Patents, Designs and Trade Marks Act 1883, and other related legal enactments.

The granting of patents for inventions with a proviso for limited terms, consistent with principles established by Acts of Parliament.

The assurance and preservation of charters of London and other corporations, as per statutory confirmations and repeals from historical legislative acts.

The reaffirmation of the divine law and the acknowledgment of God as the ultimate sovereign over the nation, as historically recognized by His Majesty's Parliament in the year of our Lord Sixteen Hundred and Ten.

AND WHEREAS it is necessary for this Honourable House to grant authority and recognition to the letters patent, laws, and declarations herein to ensure their efficacy and enforceability:

YOUR PETITIONER THEREFORE HUMBLY PRAYS that your Honourable House may be pleased to:

Receive, consider, and adopt the provisions of this Private Bill as law.

Declare and affirm the issuance of the "Lancelot THE FIRST Bill" as valid and binding.

Recognize the undersigned as rightful and lawful sovereign over the territories and peoples declared herein.

Grant such further and additional measures as may be deemed necessary and expedient for the peace, governance, and prosperity of the realm.

To the Most High and Mighty, by the Grace of God, King Lancelot Junior Webb, known hereafter as Lancelot, THE FIRST,

In the year of our Lord God 2025, on the sixth day of January, by divine providence and royal inheritance, Sovereign of Jamaica, England, Scotland, France, Spain, Liberia, Lydia, Egypt, Ethiopia, Congo, and Ireland, Defender of the Faith, and Keeper of Sacred Trusts,

A PETITION FOR A PRIVATE BILL, ENTITLED "LANCELOT THE FIRST BILL"

To all to whom these present letters shall come, Greetings. Know ye that for the glory of Almighty God, the preservation of divine justice, and the safeguarding of the dignity of sovereignty, I, Lancelot Junior Webb, hereby declare and seek ratification of my independence and dominion as Lancelot, THE FIRST.

Whereas it is meet and right to establish by authority a new order of governance and honor, in the tradition of the King's Men and the illustrious legacy of the Book of Common Prayer, and whereas the rights and liberties conferred by letters patent are a sacred trust between ruler and people:

Be it therefore enacted, by the sovereign authority of Lancelot THE FIRST, that all monopolies, dispensations, and penalties heretofore repealed by the Statute Law (Repeals) Act of 1969, and other such Acts of Parliament, shall be reaffirmed for the purpose of granting unto this reign its rightful jurisdiction.

Be it further ordained, that all patents for new inventions, as prescribed by the Proviso of 14 Years or less, shall henceforth be reconstituted under the sovereign grace of this declaration, such patents being instruments of divine and civil advancement.

Let it be known, that the Charters of London and other Corporations shall be confirmed under the dominion of Lancelot THE FIRST, granting all privileges therein to advance the commonwealth and the righteous cause of liberty.

By this proclamation, the law of God, as revealed in His holy scriptures and upheld by the Act of Parliament in the year of our Lord 1610, is hereby recognized as the supreme law of the land, binding upon all subjects and institutions.

And so, in consideration of faithful and acceptable service rendered, and for the advancement of peace and justice among the nations, let these declarations be inscribed and recorded for perpetuity.

In witness whereof, I, Lancelot Junior Webb, by the grace of Almighty God and with the assent of divine providence, affix my royal seal to this petition, decreeing it as law within all realms and dominions subject to my sovereignty.

Given under my hand and seal, this sixth day of January, in the year of our Lord God Two Thousand and Twenty-Five.
