Petition for a Private Bill: inclusion in the Act of Settlement (1700) 1700 CHAPTER 2 12 and 13 Will 3 for the further Limitation of the Crown and better securing the Rights and Liberties of the Subject, including Lord Lancelot Junior Webb

To the Honourable the Commons of the United Kingdom of Great Britain and Northern Ireland in Parliament assembled:

SHEWETH:
