The programme will conduct a two-year independent scrutiny and investigation into how the Police and Justice Act 2006 affects:

- Psychological safety and wellbeing
- Health inequalities
- Safeguarding outcomes
- Trust between institutions and Commonwealth communities

It will produce actionable recommendations for Parliament, local authorities, health bodies, and justice agencies.
